We further warrant that we are in a fit state of health to play and understand that while risk management strategies are in place at our venue, I participate in Tag League knowing that injuries may still occur.

Signature: All players have signed this registration form confirming that they have read and understood the Conditions of Play on the reverse of this sheet.

Any player that has not signed this registration form or not paid their Individual Registration Fee are not a registered player and cannot participate. Teams who allow unregistered players to participate will face disciplinary action.



#### **CONDITIONS OF PLAY, SPRING 2022.**

The Fairfield Tag League competition is affiliated with the Tag League Association Inc. ("Tag League"). The Fairfield Tag League competition is managed by Sportworx (ABN: 50602420842) on behalf of the Tag League Association Inc. (INC1300401). Fairfield Tag League offers to provide access to the competition to Players on provision by Players of the registration fee and agreement to these Conditions of Play.

#### As a Player, I agree and understand: Subject to these Conditions,

- 1.1 Qualification of any team for the semi finals will depend upon validly signed and completed registration forms for all Players being submitted.
- 1.2 I play at my own risk.
- 1.3 I will not wear football boots with screw in type studs (metal, nylon or spikes).
- 1.4 I will wear shoes suitable to playing the sport whilst playing I will not play in bare feet.
- 1.5 I will not wear jewellery (which includes men's watches) while playing.
- 1.6 I will not talk to the referee unless I am the captain of a team.
- 1.7 I will not sledge either the opposition or my own team members. This is a major offence and will result in me being sent off.
- 1.8 I must comply with the referee's directions and decisions.
- 1.9 I must play in approved Tag League shorts.
- 1.10 Any injury I sustain must be reported on the night of the injury.
- 1.11 All teams must wear numbered shirts with numbers either clearly identified on both sleeves or with one large number on the back of the shirt.
- 1.12 Changes may occur to the competition during the competition. Information regarding any changes will be placed on the competition web site (<a href="http://www.fairfieldtagleague.com.au">http://www.fairfieldtagleague.com.au</a>) each week. Teams and Players are recommended to check these notices as these changes may affect them.
- 1.13 Fairfield Tag League's policy is that ALL scheduled rounds of a competition will be played. If for any reason beyond our control rounds of the season cannot be played, all registered players will receive a pro-rata credit or refund of their season fees.

# Liability

- 2.1 Players acknowledge that there is a real possibility of injury in playing in the Fairfield Tag League competition. The most common injuries are ankle and knee injuries, broken bones, but may include any form of injury, including in rare cases, death. Tag League is a recreational activity (and may be determined to be a dangerous recreational activity) for the purpose of the Civil Liability Acts in the various States & Territories of Australia. In accordance with that legislation, you assume all risk in relation to participation in Tag League games and related activities, and you acknowledge that these conditions constitute a risk warning in respect of the risk of injury and death referred to above. By registering with Tag League and/or participating in activities organised by Tag League, you accept these risks.
- 2.2 Further, Tag League is not liable in negligence or contract for harm suffe<mark>red by you or any</mark> other person as a result of the materialisation of an obvious risk of a dangerous recreational activity engaged in by the person suffering harm. This applies whether or not you were aware of the risk.
- 2.3 I acknowledge that Tag League:
  - 2.3.1 Does not take out or maintain any insurance policy in respect of my participation in Tag League activities; and
  - 2.3.2 Hereby advises me to obtain my own private health insurance suitable for my needs.

## As a Player, I warrant that:

- 3.1 I am in a fit state of health to play.
- 3.2 I will not be under the influence of alcohol or drugs that may adversely affect me while playing.
- 3.3 I have no pre-existing medical or other conditions which might cause me injury or be aggravated by playing.
- 3.4 I have read and understood these Conditions of Play.
- 3.5 I will comply with these Conditions of Play.

### Release

- 4.1 I hereby RELEASE Tag League and its associated parties, including without limitation, its members, officers, servants and agents, contractors, volunteers, referees and any other person engaged by Fairfield Tag League in any capacity (including but not limited to Sportworx "Tag League Party") from all liability for loss of any nature, including without limitation, all personal injury, including assault or battery, economic loss sustained from personal injury, damage to property, whether arising out of negligence, breach of any statutory duty, breach of contract or at common law.
- 4.2 I acknowledge and represent that any Tag League Party regardless of their connection with me may rely on this release. This release from liability applies unless specifically prohibited by statute.
- 4.3 Without limiting clause 4.1, Tag League and each Tag League party expressly excludes all liability for death or personal injury to any person in so far as such liability is capable of being excluded by law.
- 4.4 The Registration Form is an "Important Notice" and constitutes a risk warning for the purposes of the Civil Liability Act 2002 NSW and any other legislation having a similar purpose.
- 4.5 These Conditions of Play represent the entire agreement and understanding between Fairfield Tag League and the Player and bind the Player's heirs, successors and assigns.
- 4.6 Tag League will not waive or vary any of these Conditions of Play unless it does so by notice in writing.
- 4.7 Without affecting any of the above releases, Tag League has the discretion under its Member Support Policy to make a payment of up to \$2000 per member per year to cover expenses incurred as the result of a serious injury incurred during a sanctioned Tag League event. A written application process, with supporting evidence, is required and conditions apply. Tag League has full discretion to pay or not pay any such amounts and Tag League's decision is final and binding.
